FOR CHAPTERS WITH NON COMPLIANCES ON CPD POST

IECEP as the Accredited and Integrated Professional Organization for Electronics Engineering Professionals of the Professional Regulation Commission and through the guidance of the Professional Regulatory Board of Electronics Engineering and its CPD Council is hereby expected to adhere on compliances set forth by the Commission. Post Event Completion Reports and Attendance Sheets are required compliances for AIPOs and their Chapters with approved and accredited CPD Programs.

In lieu of this, all Chapters with Non-compliances for Post Event Completion Reports and Attendance Sheets with more than six (6) in count or number or equivalent shall be *temporarily suspended* of applying for CPD Accredited Programs prior to submission of ALL its Non-Compliances. Each Chapter is hereby given a Maximum of Forty-Five (45) Days to address and complete deficiencies by coordinating with the CPD Completion and Monitoring Committee chaired by the National Auditor and ably supported by the CPD National Secretariat.

Accomplishment reports for deficiencies shall be compiled and submitted to the National CPD Secretariat (<a href="mailto:cpd@iecepnational.com">ccept@iecepnational.com</a>), the National Secretariat (<a href="mailto:secretariat@iecepnational.com">secretariat@iecepnational.com</a>), the National Auditor (<a href="mailto:auditor@iecepnational.com">auditor@iecepnational.com</a>) and the National Secretary General (<a href="mailto:secretary.general@iecepnational.com">secretary.general@iecepnational.com</a>). Compliance to this Order shall be duly considered support to National issuances and related recognitions.
